The show is 40 minutes North of White Plains NY and 15 Min. West of Danbury CT. Walking distance from the Metro North ~ Harlem Line ~ Patterson Station

COST: Tables are 8 feet long at a cost of **\$45 per table**. Application and fee are due prior to the show. *Tables will be available on a First Come basis.* Aisles are 6 feet wide.

SETUP: Dealers may set up at **7 AM** and must be completed by **9AM**. Be very careful to protect this fine facility. *Please unload your vehicle and move it to the parking area, so others may unload. Parking is plentiful.

DIRECTIONS:

From **North**- I-87 and I-91 intersect with I-84 either East or West, to Exit 18. From Exit 18 follow signs to Patterson, Route 311. I-95 to Connecticut Rte 34 to I84 West. Exit 18 follow signs to Patterson, Route 311. Follow signs to the show.

From **East** - Take I-84 West to Exit 18 follow signs to Patterson, Route 311. Follow signs to the show.

From **South** - Take Hutchinson River or Sawmill River parkways North to I684. Then Take I-84 West to Exit 18. Follow signs to Patterson Route 311. Follow signs to the show.

From **West** - Make your way to I-84 Exit 18 to Patterson, Route 311. Follow signs to the show.

Food & Beverage will be available throughout the day for purchase at the snackbar.

2. ***AMMUNITION:** **NO** Live Ammunition Of Any Kind. (This includes unfired blanks & black powder).
3. ***MAGAZINES:** **ONLY** 10 Round Capacity or Less will be permitted for sale.
4. ***Firearm accessories are OK!**
5. Doors open @ 7am for table setup, setup must be completed by 9AM.....Please do not pack up until 3PM.
6. All booths must be kept safe and presentable and be left spotless at the close of the show. If we want the show to continue, we must all do our part to respect the facility.
7. This show is advertised as a family event. Please **NO** obscene or racist materials of any kind. Third Reich memorabilia is welcome, but must be tastefully displayed. *The management reserves the right to have any items it deems inappropriate removed from the show area.*
8. **FULL DISCLOSURE:** Each exhibitor is obligated to honestly and properly present his merchandise at all times. A quality show will attract quality buyers.
9. Tables and isles have been set up to meet all fire regulations please **DO NOT** block isles or re-arrange tables.
10. There will be **NO** selling of any kind in the parking lot.
11. **NO** subletting of tables is allowed.
12. The Exhibitor is responsible for any state and local taxes or the collection thereof.
